“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated October 20, 2014, forwarding Resolution No. 95, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Training Expenses under the Regular Budget of the Office of the Provincial Treasurer in the amount of ₱150,000.00 to be taken from item Financial Expenses (Documentary Stamps);

“Funds having been certified as available by the Provincial Accountant per his certification dated September 11, 2014;

“On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 48
(Series of 2014)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Training Expenses under the current budget of the Provincial Treasurer’s Office in the amount of ₱150,000.00 to be taken from item Financial Expenses (Documentary Stamps) of same office.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2014.

“Enacted, November 25, 2014.”
