“Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated November 3, 2014, forwarding Resolution No. 110, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Food Supplies Expenses under the current budget of the Negros Oriental Detention and Rehabilitation Center in the amount of ₱295,000.00 to be taken from the allocation of other MOOE items under the same office.

“Funds having been certified as available by the Provincial Accountant per his certification dated October 28, 2014;

“On motion of Honorable Member Liland Zoila B. Estacion, seconded by Honorable Member Erwin Michael L. Macias, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 49
(Series of 2014)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for items Food Supplies Expenses under the current budget of the Negros Oriental Detention and Rehabilitation Center in the amount of ₱295,000.00, to be taken from the following items:

Drugs and Medicines Expenses.....	₱130,000.00
Traveling Expenses – Local.....	65,000.00
Telephone Expenses – Mobile.....	18,000.00
Gasoline, Oil and Lubricants Expenses.....	72,000.00
Repairs & Maintenance – Motor Vehicles.....	10,000.00




