"RESOLVES, To approve Resolution No. 30, current series, of the Negros Oriental Provincial Development Council Executive Committee; and Addendum No. 30 of the Annual Investment Program for Calendar Year 2016, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

### APPROPRIATION ORDINANCE NO. 24 (Series of 2016)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\mathbb{P}25,000.00\$ representing existing unobligated allotment balance of the allocation for the Rehabilitation and Repair of Spillway Connecting Apolong-Sagbang Road, Sagbang, Valencia, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated to fund the Rehabilitation of Multipurpose Hall, same barangay.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
