
“Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator, this province, dated December 8, 2016, transmitting Resolution No. 16, current series, of the Local Finance Committee, this province, anent the request of Dr. Edgardo P. Pialago, Chief of Hospital I, GWBVMH, for augmentation of funds in the amount of ₱8,000.00 for item Taxes, Duties and Licenses under the Regular Budget of the Governor William ‘Billy’ Villegas Memorial Hospital, to be taken from item Insurance Expenses of same budget;

“Funds having been certified as available by the Officer-In-Charge, Provincial Accountant’s Office per certification dated December 1, 2016;

“On motion of Honorable Member Jaime L. Reyes, seconded by Honorable Member Peve O. Ligan and Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 29
(Series of 2016)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:





Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Taxes, Duties and Licenses under the Regular Budget of the Governor William ‘Billy’ Villegas Memorial Hospital in the amount of ₱8,000.00, to be taken from item Insurance Expenses under the same budget.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2016.
