## APPROPRIATION ORDINANCE NO. 29 (Series of 2016)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Taxes, Duties and Licenses under the Regular Budget of the Governor William 'Billy' Villegas Memorial Hospital in the amount of \$\pi\_8,000.00\$, to be taken from item Insurance Expenses under the same budget.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2016.
