APPROPRIATION ORDINANCE NO. 21 (Series of 2017)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Vice Governor is hereby authorized to augment the appropriation for items Training Expenses and Office Supplies Expenses under the current budget of the Office of the Secretary to the Sanggunian in the amount of \$185,000.00 and \$15,000.00, respectively, to be taken from item Enhancement of the Legislative Tracking System, same budget.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2017.
