“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱2,699,138.41 representing existing unobligated allotment balance of the allocation for the Concreting of Valencia-Palimpinon Road, Valencia, Negros Oriental under the 2015 20% Development Fund is hereby reverted to the unappropriated balance; the same amount is likewise appropriated for the Concreting of Jawa-Bongbong Road Section, same municipality;

Section 2. The amount of ₱700,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Box Culvert, Sitio Apoya, Barangay Manalongon, Sta. Catalina, under the 2012 20% Development Fund is hereby reverted to the unappropriated balance; the same amount is likewise appropriated for the Concreting of Road in Sitio Apoya, same barangay;


