“Presented for consideration before the August Body was the letter of the Provincial Administrator, this province, dated August 5, 2020, transmitting Resolution No. 48, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for various MOOE items of the Prevention, Control and Mitigating Measures of Livestock and Poultry Diseases Program under the budget of the Office of the Provincial Veterinarian in the sum of ₱150,900.00 to be taken from item Training Expenses of the same program;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR VARIOUS MOOE ITEMS OF THE PREVENTION, CONTROL AND MITIGATING MEASURES OF LIVESTOCK AND POULTRY DISEASES PROGRAM IN THE SUM OF ₱150,900.00 TO BE TAKEN FROM ITEM TRAINING EXPENSES OF THE SAME PROGRAM.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for various MOOE items of the Prevention, Control and Mitigating Measures of Livestock and Poultry Diseases Program under the budget of the Office of the Provincial Veterinarian to be taken from item Training Expenses of the same program in the sum of ₱150,900.00, viz:

Office Supplies Expenses.....	₱ 4,520.00
Drugs and Medicines Expenses.....	82,240.00
Fuel, Oil and Lubricants Expenses.....	64,140.00


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the item Training Expenses for Calendar Year 2020.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


