“Whereas, the request for appropriation in the amount of ₱2,600,000.00 to fund the activity ‘Information Education Campaign (IEC) of the Negros Oriental Task Force to End Local Communists Armed Conflict (NOTF-ELCAC)’ was returned since there was no Program of Work attached to support the same;

“Funds having been certified as available by the Provincial Accountant and Provincial Treasurer;

“On motion of Honorable Member Erwin Michael L. Macias, seconded by Honorable Member Valente D. Yap and Honorable Member Kit Marc B. Adanza, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance:

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱8,330,000.00 TO COVER PROGRAMS/PROJECTS/EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱850,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund to cover expenditures relative to the Equipment for Computerization Project (Computerization of Property Approval System) of the Provincial Assessor's Office, to wit:

11 Units Workstation (Desktop and Printer).....	₱550,000.00
1 Unit Server.....	80,000.00
Internet and Network Connection.....	40,000.00
1 Unit Map Scanner (Flatbed Scanner – A3).....	180,000.00

Section 2. The amount of ₱4,100,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund for the Repair/Rehabilitation of the Malaunay-Dungga-Inas-Dobdob Provincial Road, Valencia, Negros Oriental.

Section 3. The amount of ₱3,300,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund for the Construction of Spillway/Box Culvert at Panayawan Creek 2, Tuyop Tuyop, Barangay Bago, Tayasan, Negros Oriental.

Section 4. The amount of ₱80,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operations of the General Fund to cover the implementation of the Water Supply Program (Purchase of Water Pipes/PE Tube #1/2) for Communal Use for Distribution to Different Barangays in the 1st District, to wit:
