“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱202,000.00 is hereby reverted to the unappropriated balance of the 20% Development Fund, representing Continuing Allotments under the Mabinay Medicare Community Hospital, to wit:

Upgrading of the Laboratory of the Mabinay
MCH (Purchase of Blood Analyzer).....₱102,000.00

Purchase of Diagnostic Set and Other
Hospital Equipment for the Mabinay
Medicare Community Hospital..... 100,000.00

Section 2. The amount of ₱202,000.00 is, likewise, appropriated for Medical, Dental and Laboratory Equipment – Electrolyte Analyzer Machine of the Mabinay Medicare Community Hospital.

Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.



Section 4. This Appropriation Ordinance shall take effect immediately upon approval.


