“RESOLVES, To approve Resolution No. 13, current series, of the Provincial Development Council, this province, and Addendum No. 16 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 18
(Series of 2017)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,800,000.00 representing existing unobligated allotment balance from the allocation for the project Additional Appropriation for the Development of Apo Island Tourism Site, Dauin, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of ₱1,800,000.00 is hereby appropriated from the unappropriated balance of the 20% Development Fund for the Concreting of Road in Barangay Panubtuban, Dauin.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
