"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Other Supplies and Materials Expenses under the Regular Budget of the Canlaon District Hospital in the amount of \$\mathbb{P}\$100,000.00 to be taken from item Repairs and Maintenance – Transportation Equipment, same budget.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
