“RESOLVES, To enact the following Appropriation Ordinance:

(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱5,400,000.00 TO COVER THE GRANT OF GRATUITY PAY FOR FISCAL YEAR 2020 TO CONTRACT OF SERVICE AND JOB ORDER WORKERS IN GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:



Section 1. The amount of ₱5,400,000.00 representing current Personal Services Savings – Salaries and Wages (Regular) including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated to cover the Grant of Gratuity Pay for Fiscal Year 2020 to Contract of Service and Job Order Workers in Government at ₱3,000.00 each, pursuant to Administrative Order No. 38 dated December 28, 2020.



Section 2. This Appropriation Ordinance shall take effect immediately upon approval.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
