“Be it enacted by the Sangguniang Panlalawigan that:



Section 1. The amount of ₱165,000.00 representing Personal Services savings under the General Fund Proper is hereby appropriated for items Electricity Expenses and Water Expenses under the Governor’s Office to cover electricity and water expenses of the Office of the Election Supervisor, in the amount of ₱95,000.00 and ₱70,000.00, respectively, provided that a separate meter should be installed in the Office of the Provincial Election Supervisor in the coming year.


Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
