"Presented for legislative authorization before the August Body was Supplemental Budget No. 17 of the General Fund for Calendar Year 2020 in the amount of ₱655,996.90 to fund various expenditures of the provincial government;

"Funds having been certified as available by the Provincial Accountant and Provincial Treasurer per Certifications dated May 29, 2020 and June 29, 2020;

"On motion of Honorable Member Chester V. Lim, seconded by Honorable Member Ma. Antonia E. Villegas, the Sangguniang Panlalawigan, in session duly assembled

"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 35
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱655,996.90 TO FUND VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱50,000.00 representing Savings from Operations under the General Fund for Calendar Year 2019, is hereby

appropriated to fund Water Expenses of the Governor's Office for the period from February to December, 2020.

Section 2. The amount of ₱605,996.90 representing Savings from Operations under the General Fund for Calendar Year 2019, is hereby appropriated to cover prior year's expenditures incurred in the conduct of activities to End Local Communist Armed Conflict (ELCAC), to wit:

Ms. Ann's Foodtown.....	₱ 488,672.00
Ms. Ann's Foodtown.....	15,000.00
Carol Enterprises.....	13,041.00
LJIM Trading.....	15,168.30
LJIM Trading.....	74,115.60


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.

Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


