AN ORDINANCE APPROPRIATING THE AMOUNT OF \$\phi_2,099,386.17 TO FUND VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.



"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\pi\265,678.50\$ representing current Personal Services Savings - Salaries and Wages (Regular) of the Negros Oriental Provincial Health Office is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Terminal Leave Benefits of the following health personnel:
