"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 13  
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,168,000.00 FOR THE PURCHASE OF ONE (1) UNIT OUTBOARD ENGINE.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,168,000.00 representing Accounts Payable (P3-9998-016(14)12-4484-14) under the General Fund Proper is hereby reverted to the unappropriated balance; the same amount is likewise appropriated for the Purchase of One (1) Unit Outboard Engine.



Section 2. This Appropriation Ordinance shall take effect immediately upon approval.



Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


