APPROPRIATION ORDINANCE NO. 9 (Series of 2021)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM TERMINAL LEAVE BENEFITS UNDER THE CURRENT REGULAR BUDGET OF THE CONG. LAMBERTO L. MACIAS MEMORIAL HOSPITAL IN THE AMOUNT OF ₱18,380.20.



"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Terminal Leave Benefits under the current Regular Budget of the Cong. Lamberto L. Macias Memorial Hospital in the amount of \$\mathbb{P}\$18,380.20, to be taken from item Salaries and Wages - Regular Pay, to cover the Terminal Leave Benefits of Ms. Marina S. Solis, former Nutritionist-Dietitian II of same hospital.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
