“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Office Supplies Expenses under the current budget of the Provincial Legal Office in the sum of ₱200,000.00, to be taken from the following items:

Traveling Expenses .....	₱100,000.00
Training Expenses .....	100,000.00


