"Whereas, presented for consideration before the August Body was the letter of the Provincial Administrator, this province, dated May 8, 2014, requesting for the augmentation of funds for item Overtime and Night Pay of the Provincial Accountant's Office in the amount of \$\mathbf{P}100,000.00\$ to be taken from item Salaries and Wages – Regular Pay of same office;

"On motion of Honorable Member Chester V. Lim, seconded by Honorable Member Melliemoore M. Saycon, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

## APPROPRIATION ORDINANCE NO. 20 (Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Overtime and Night Pay under the current budget of the Provincial Accountant's Office in the amount of \$\pi\$100,000.00 to be taken from the item Salaries and Wages – Regular Pay of same office.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations, and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2014.

Section 3. This supersedes Sangguniang Panlalawigan Resolution No. 376 dated May 12, 2014.
