The amount of \$3,500,000.00 representing current Personal Services savings of the General Fund Proper including Devolved Hospitals is hereby appropriated as Subsidy for the Construction of LGU Booths at the Capitol Area and Subsidy for Festival of Festivals LGU Participation and other related Buglasan Expenses.
