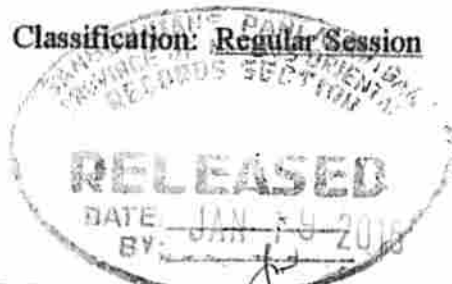

"Whereas, presented for consideration before the August Body was the letter of the Honorable Governor, this province, dated November 20, 2014, forwarding Resolution No. 115, current series, of the Local Finance Committee, favorably recommending the augmentation of funds for item Water Expenses under the current budget of the Office of the Provincial Engineer in the amount of ₱200,000.00 to be taken from the allocation of other MOOE items under the same office;

"Funds having been certified as available by the Provincial Accountant per his certification dated November 7, 2014;

"On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Liland Zoila B. Estacion, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 56
(Series of 2014)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Water Expenses under the current budget of the Office of the Provincial Engineer in the sum of ₱200,000.00, to be taken from other MOOE items under the same budget, viz:


Office Supplies Expenses.....	₱ 50,000.00
