APPROPRIATION ORDINANCE NO. 10 (Series of 2015)

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Vice Governor is hereby authorized to augment the appropriation for item Other Supplies Expenses under the current budget of the Sangguniang Panlalawigan in the amount of \$\mathbb{P}\$200,000.00 to be taken from item Traveling Expenses – Local.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2015.
