"RESOLVES, To approve Addendum No. 40 of the Annual Investment Program for Calendar Year 2015, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 29
(Series of 2015)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱44,682,240.00 representing Personal Services savings of the different offices including devolved hospitals of the Province of Negros Oriental as of December 7, 2015 is hereby appropriated for the Monetization of Leave Credits of Provincial Employees for a maximum of thirty (30) days leave credits.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
