“Whereas, presented for consideration before the August Body was the letter of the Assistant Provincial Administrator dated December 11, 2015, requesting for augmentation of funds for item Repairs & Maintenance-Motor Vehicles under the current budget of the Dawis Community Primary Hospital, in the amount of ₱57,625.00, to be taken from other MOOE items;

“Funds having been certified as available by the Provincial Accountant per his certification dated November 6, 2015;

“On motion of Honorable Member Edmund F. Dy, seconded by Honorable Member Liland Zoila B. Estacion and Honorable Member Rommel L. Erames, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 37
(Series of 2015)

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the appropriation for item Repairs & Maintenance-Motor Vehicles under the current budget of the Dawis Community Primary Hospital, in the amount of ₱57,625.00, to be taken from other MOOE items, viz:

Cable, Satellite, Telegraph and Radio Expenses.....	₱ 7,200.00
Repairs & Maint. – Hospital & Health Centers.....	44,425.00
Other Maintenance and Operating Expenses.....	6,000.00


Section 2. The amount of ₱57,625.00 shall be solely utilized for the Purchase of Tires and other Ambulance parts, per letter request of the CPH Supervisor dated October 7, 2015.

Section 3. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2015.


