“Presented for legislative authorization before the August Body was Supplemental Budget No. 58 of the General Fund – 20% Economic Development Fund in the amount of ₱2,819,465.00 for the Purchase of Lots for Evacuation Center and Livelihood/Entrepreneurship/Local Development Project in the Municipality of Amlan, per Resolution No. 50, current series, of the Provincial Development Council Executive Committee, with the corresponding Addendum No. 60 of the Annual Investment Program for Calendar Year 2015;

“Funds having been certified as available by the Provincial Accountant per his Certification dated August 10, 2015;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Erwin Michael L. Macias, Honorable Member Liland Zoila B. Estacion, and Honorable Member Chester V. Lim, the Sangguniang Panlalawigan

“RESOLVES, To approve Resolution No. 50, current series, of the Provincial Development Council Executive Committee, this province, and Addendum No. 60 of the Annual Investment Program for Calendar Year 2015, subject to the usual accounting and auditing rules, regulations and policies;

“RESOLVES FURTHER, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 58
(Series of 2015)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱1,019,465.00 representing existing unobligated allotment balance allocated for Construction of Multipurpose Hall/Evacuation Center, Poblacion, Amlan, for Calendar Year 2014 is hereby reverted to the

unappropriated balance of the 20% Economic Development Fund; the sum of ₱2,819,465.00 is likewise appropriated from the unappropriated balance of the 20% Economic Development Fund and existing unobligated allotment balance of the Additional Funding for the Construction of Multipurpose Building/Evacuation Center, Barangay Poblacion, Amlan, to fund the following:

Purchase of Lot adjacent to the Municipal Hall Building intended for Evacuation Center, Amlan ₱1,019,465.00

Purchase of Lot for Implementation of Livelihood/Entrepreneurship/Local Development Project, Amlan 1,800,000.00

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
