### RESOLUTION NO. 949

"Presented for legislative authorization before the August Body was Supplemental Budget No. 34 of the General Fund - 20% Development Fund for Calendar Year 2017 in the amount of ₱500,000.00 for the Construction of Seawall, Barangay Tapon Norte, San Jose, as embodied under Resolution No. 16a, current series, of the Provincial Development Council, with the corresponding Addendum No. 34 of the Annual Investment Program for Calendar Year 2017;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office per her certification dated July 10, 2017;

"On motion of Honorable Member Rommel L. Erames, seconded by Honorable Member Nilo D. Sayson, the Sangguniang Panlalawigan

"RESOLVES, To approve Resolution No. 16a, current series, of the Provincial Development Council and Addendum No. 34 of the Annual Investment Program for Calendar Year 2017, subject to the usual accounting and auditing rules, regulations and policies;

"RESOLVES FURTHER, To enact the following Appropriation Ordinance:

## APPROPRIATION ORDINANCE NO. 36 (Series of 2017)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\pi\$500,000.00 representing unobligated allotment balance of the allocation for Construction of Multipurpose Building/Evacuation Center, Tapon Norte, San Jose, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Development Fund.

Section 2. The amount of \$\pi 500,000.00\$ is hereby appropriated from the unappropriated balance of the 20% Development Fund, for the Construction of Seawall, Barangay Tapon Norte, San Jose, Negros Oriental.

Section 3. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
