# APPROPRIATION ORDINANCE NO. 46 (Series of 2019)

AN ORDINANCE APPROPRIATING THE AMOUNT OF \$1,659,028.46 TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of \$374,804.48 representing Continuing Allotments under the Provincial General Services Office per Certifications of the Officer-In-Charge, Provincial Accountant's Office dated September 19, 2019 and November 4, 2019 (hereto attached as Annexes "A" and "B") is hereby reverted
