"Presented for consideration before the August Body was the letter of the Provincial Administrator, this province, dated November 3, 2020, transmitting Resolution No. 89, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for item Water Expenses under the budget for the Operation/Administration of the Provincial Integrated Skills Training Center in the sum of P167,012.00 to be taken from other MOOE items;

"On motion of Honorable Member Valente D. Yap, seconded by Honorable Member Erwin Michael L. Macias and Honorable Member Adem B. Maxino, the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

## APPROPRIATION ORDINANCE NO. 25 (Series of 2020)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM WATER EXPENSES UNDER THE BUDGET FOR THE OPERATION/ADMINISTRATION OF THE PROVINCIAL INTEGRATED SKILLS TRAINING CENTER IN THE SUM OF \$\mathbf{p}\$167,012.00 TO BE TAKEN FROM OTHER MOOE ITEMS.

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation for item Water Expenses under the budget for the Operation/Administration of the Provincial Integrated Skills Training Center in the sum of \$\mathbb{P}167,012.00\$ to be taken from other MOOE items under the same budget, viz:

Traveling Expenses-Local	9 8,000.00
Electricity Expenses	130,000.00
Repairs and Maintenance	4,012.00
Insurance Expenses	10,000.00
Other Maintenance and Operating Expenses	15,000.00

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
