

AN ORDINANCE APPROPRIATING THE AMOUNT OF \$\mathbf{p}\$500,000.00 FOR THE CONSTRUCTION OF TABO SA PAO (PHASE 1).



"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\pi 500,000.00\$ representing unexpended allocation for the Construction of Bagsakan Center at PAO Compound, Dumaguete City, Negros Oriental, under the Calendar Year 2014 Annual Budget is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Construction of Tabo sa PAO (Phase 1).

- Section 2. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.
- Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
