“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱5,000,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operation of the General Fund for the

Repair/Rehabilitation/Improvement of the Old Barracks at Camp Leon Kilat, Barangay Sta. Cruz Viejo, Tanjay City, to be converted into a Museum for the Memorabilia of the Negrense Warriors for Peace.

Section 2. The amount of ₱5,000,000.00 is hereby appropriated from the Calendar Year 2020 Savings from Operation of the General Fund for the Construction of Negros Oriental Police Provincial Office (NOPPO) Grandstand and Roofing of the NOPPO Multipurpose Gym/Basketball Court, Camp Lt. Col. Francisco C. Fernandez, Jr., Barangay Agan-an, Sibulan, Negros Oriental.


Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.


Section 4. This Appropriation Ordinance shall take effect immediately upon approval.

Section 5. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


