“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱880,460.00 representing current Personal Services savings of the General Fund Proper including devolved Hospitals is hereby appropriated for the Governor’s Sports Festival-Buglasan Sports.



The amount of ₱2,850,000.00 is hereby appropriated from the existing surplus of the General Fund for Calendar Year 2013 as additional appropriation for item Donations – Assistance to Individuals in Crisis Situation under the budget of the Provincial Social Welfare and Development Office.
