

"Presented for legislative authorization before the August Body was Supplemental Budget No. 54 of the General Fund for Calendar Year 2018 in the amount of \$\pi 309,117.60\$ to cover the Salaries and Wages and other benefits of three (3) Casual Employees for six (6) months effective July 1, 2018;

"Funds having been certified as available by the Officer-In-Charge, Provincial Accountant's Office, and In-Charge of Office, Provincial Treasurer's Office;

"On motion of Honorable Member Jessica Jane J. Villanueva, seconded by Honorable Member Georgita F. Martinez, the Sangguniang Panlalawigan, in session duly assembled

"RESOLVES, To enact the following Appropriation Ordinance:

# APPROPRIATION ORDINANCE NO. 73 (Series of 2018)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of \$\pi 309,117.60\$ representing existing unobligated balance available from Personal Services as of April, 2018 is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Salaries and Wages and other benefits of three (3) Casual Employees under the Office of the Governor for six (6) months effective July 1, 2018, namely: Adam A. Cantila, Isabelito A. Catalan and Necito C. Catubo, broken down as follows:

Salaries & Wages - Casual/Contractual \$\mathbb{P}\$189,180.00
Personnel Economic Relief Allowance (PERA) 36,000.00
