Section 1. The amount of \$\psi_0,000.00\$ representing existing allotment balance of the allocation for the Rehabilitation of Multipurpose Hall, Barangay Sagbang, Valencia, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Improvement of Multipurpose Hall, Barangay Sagbang, Valencia.
