“RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 7
(Series of 2019)

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱400,000.00 representing existing allotment balance of the allocation for the Construction of Multipurpose Hall Barangay Bajumpandan, Dumaguete City, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Improvement and Concreting of an Interior Road, Habitat 1, Bajumpandan, Dumaguete City.

Section 2. The amount of ₱2,535,974.20 representing existing allotment balance of the allocation for the Concreting of Farm-to-Market Road, So. Punglo, Barangay Sto. Niño, Tanjay City, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Concreting of Farm-to-Market Road, So. Busay, Barangay Sto. Niño, Tanjay City.

The amount of ₱1,000,000.00 representing existing allotment balance of the allocation for the Concreting of Crossing Looc-Balugo Road Including the Cross Drainage, Barangay Looc, Sibulan, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Improvement and Rehabilitation of Looc-Balugo Road, Barangay Looc, Sibulan.


Section 4. The amount of ₱50,000.00 representing existing allotment balance of the allocation for the Rehabilitation of Multipurpose Hall, Barangay Sagbang, Valencia, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Improvement of Multipurpose Hall, Barangay Sagbang, Valencia.

Section 5. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.


