RESOLUTION NO. 568

“Presented for legislative authorization before the August Body was Supplemental Budget No. 3 of the General Fund for Calendar Year 2020 in the amount of ₱35,486,326.00 to cover the Grant of Gratuity Pay to Job Order and Contract of Service Personnel as well as the First Tranche of the Modified Salary Schedule for Local Government Personnel, pursuant to Administrative Order No. 20, series of 2020, of the Office of the President and Local Budget Circular No. 121 dated January 24, 2020 pursuant to Republic Act 11466, respectively;

“Funds having been certified as available by the Provincial Accountant and Provincial Treasurer, per certifications dated May 5 and 6, 2020;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member Manuel L. Sagarbarria, the Sangguniang Panlalawigan, in session duly assembled

“RESOLVES, To enact the following Appropriation Ordinance :

APPROPRIATION ORDINANCE NO. 4  
(Series of 2020)

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱35,486,326.00 TO COVER THE GRANT OF GRATUITY PAY TO JOB ORDER AND CONTRACT OF SERVICE PERSONNEL AS WELL AS THE FIRST TRANCHE OF THE MODIFIED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNEL.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The sum of ₱10,234,945.00 representing current Personal Services Savings – Salaries and Wages (Regular) including Hospitals is hereby reverted to the unappropriated balance of the General Fund.

Section 2. The sum of ₱35,486,326.00 is hereby appropriated from the unappropriated balance of the General Fund and Underestimated Internal Revenue Allotment to cover the following:

Grant of Gratuity Pay to Job Order and Contract of Service Personnel pursuant to Administrative Order No. 20 dated January 10, 2020 by the President of the Philippines..... ₱ 5,238,000.00

First Tranche of the Modified Salary Schedule for Local Government Personnel effective January 1, 2020 per DBM Local Budget Circular No. 121 dated January 24, 2020, Implementing Republic Act 11466..... 30,248,326.00

Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.



Section 4. This Appropriation Ordinance shall take effect immediately upon approval.


