“Presented for consideration before the August Body was the letter of the Provincial Administrator, this province, dated August 5, 2020, transmitting Resolution No. 49, current series, of the Local Finance Committee, this province, favorably recommending the augmentation of funds for item Other Maintenance and Operating Expenses – Job Order in the amount of ₱197,000.00 to be taken from item Agricultural and Marine Supplies of the current allocation for Native Chicken Hatchery Production Program in Negros Oriental under the budget of the Office of the Provincial Veterinarian;

“Funds having been certified as available by the Provincial Accountant per his certification dated June 23, 2020;

“On motion of Honorable Member Ma. Antonia E. Villegas, seconded by Honorable Member John T. Raymond, Jr., the Sangguniang Panlalawigan of Negros Oriental, in session duly assembled, hereby enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 9
(Series of 2020)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEM OTHER MAINTENANCE AND OPERATING EXPENSES – JOB ORDER IN THE AMOUNT OF ₱197,000.00 TO BE TAKEN FROM ITEM AGRICULTURAL AND MARINE SUPPLIES OF THE CURRENT ALLOCATION FOR NATIVE CHICKEN HATCHERY PRODUCTION PROGRAM IN NEGROS ORIENTAL.

“Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:


Section 1. The Honorable Governor is hereby authorized to augment the allocation for item *Other Maintenance and Operating Expenses – Job Order* in the amount of ₱197,000.00 to be taken from item *Agricultural and Marine Supplies* of the current allocation for *Native Chicken Hatchery Production Program* in Negros Oriental under the budget of the Office of the Provincial Veterinarian.


Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter item for Calendar Year 2020.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.


