AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱247,000.00 TO COVER VARIOUS EXPENDITURES OF THE PROVINCIAL GOVERNMENT.

“Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱247,000.00 to be taken from Savings from Operation of the General Fund for Calendar Year 2020, is hereby appropriated to fund the following:

Governor’s Office	
Aid to Philippine Mental Health Association (PMHA).....	₱ 85,000.00
Provincial Treasurer’s Office	
15 Units Uninterruptible Power Supply (Good Quality).....	112,000.00
1 Unit Smart TV.....	50,000.00


Section 2. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.


Section 3. This Appropriation Ordinance shall take effect immediately upon approval.

Section 4. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
