APPROPRIATION ORDINANCE NO. 19 (Series of 2016)

"Be it enacted by the Sangguniang Panlalawigan that:

Section 1. The amount of ₱100,000.00 representing existing unobligated allotment balance of the allocation for the Construction of Barangay Health Stations (BHS) in Barangays Nabago, Malongcay and Nasig-id, all of Zamboanguita, Negros Oriental, is hereby reverted to the unappropriated balance of the 20% Development Fund; the same amount is likewise appropriated for the Repair/Improvement of Barangay Health Station, Malongcay, Zamboanguita.

Section 2. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
