The amount of ₱500,000.00 representing Personal Services savings under item Salaries and Wages – Regular Pay including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated as additional appropriation for item Pasko sa Kapitolyo and Other Culture and Arts Events.


