"RESOLVES, To enact the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 19 (Series of 2022)

AN **ORDINANCE** APPROPRIATING THE **AMOUNT** OF P2,190,000.00 FOR THE PURCHASE OF AIR CONDITIONING UNITS FOR THE SANGGUNIANG PANLALAWIGAN AND AS ADDITIONAL APPROPRIATION FOR ITEM ELECTRICITY EXPENSES OF THE PROVINCIAL GENERAL SERVICES OFFICE.

"Be it enacted by the Sangguniang Panlalawigan that:

The amount of \$390,000.00 representing unexpended allocation for item Additional Appropriation for the Purchase of 4 x 4 Vehicles

under the Sangguniang Panlalawigan is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated for the Purchase of three (3) units Air Conditioner for the same office.

- Section 2. The amount of 1,800,000.00 representing current Personal Services Savings including Hospitals is hereby reverted to the unappropriated balance of the General Fund; the same amount is likewise appropriated as additional appropriation for item Electricity Expenses of the Provincial General Services Office.
- Section 3. Disbursement of funds hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies.
- Section 4. This Appropriation Ordinance shall take effect immediately upon approval.
- Section 5. Copies of this ordinance shall be forwarded to the Regional Director, Office of Budget and Management, Region VII, Cebu City, for review, pursuant to Section 326 of Republic Act 7160.
