APPROPRIATION ORDINANCE NO. 44 (Series of 2021)

AN ORDINANCE AUTHORIZING THE HONORABLE GOVERNOR TO AUGMENT THE ALLOCATION FOR ITEMS DRUGS AND MEDICINES EXPENSES, MEDICAL, DENTAL AND LABORATORY SUPPLIES EXPENSES, REPAIRS AND MAINTENANCE – BUILDINGS AND OTHER STRUCTURES AND ELECTRICITY EXPENSES UNDER THE CURRENT REGULAR BUDGET OF THE BAIS DISTRICT HOSPITAL IN THE SUM OF \$\mathbb{P}1,091,000.00.

"Be it ordained by the Sangguniang Panlalawigan of Negros Oriental that:

Section 1. The Honorable Governor is hereby authorized to augment the allocation of MOOE items under the current Regular Budget of the Bais District Hospital, viz:

Expenses – Job Order	190,000.00.

Section 2. Implementation hereof is subject to the usual budgeting, accounting and auditing rules, regulations and policies, provided that no additional appropriation will be made on the latter items for Calendar Year 2021.

Section 3. This Appropriation Ordinance shall take effect immediately upon approval.
